Attachment, Self-Regulation, and Competency (ARC): A Comprehensive Framework for Intervention with Complexly Traumatized Youth

A substantial percentage of children exposed to trauma has experienced multiple or prolonged exposures. This workshop will discuss the ARC framework for intervention, which addresses the individual, familial, and systemic needs of this population. Treatment identifies three core domains relevant to future resiliency: attachment, self-regulation, and competency, as well as 10 building blocks of trauma-informed treatment.

Reorganizing the Disorganized Brain

This workshop will examine how trauma affects brain regions that support intense emotions while decreasing (a) activation in the CNS regions involved in the integration of sensory input with motor output, (b) the inhibition of emotional expression, (c) the organization of self-experience, and (d) the translation of experience into communicable language. We will explore how experience can reorganize the brain and how motoric actions and neurofeedback help reorganize attention and perception.

WORKSHOP III:

Attachment-Focused Trauma Treatment

This workshop focuses on the attachment relationship as a foundation and guide for trauma resolution and integration. When the client is a child, a trusted adult provides the safety that allows the child to learn more fully and quickly than with a therapist alone. Attachment figures provide a strong, lifelong source of intersubjective exploration and discovery by focusing on the development and integration of one's sensorimotor, affective, reflective, communication, and relationship abilities.

WORKSHOP IV:

Divided Mind, Divided Body: Interventions for Working with Dissociative Parts in Traumatized Individuals

Integrating theory and technique from sensorimotor psychotherapy and structural dissociation, this workshop will explore the treatment of trauma-related dissociation through slide handouts, video excerpts, role play and experiential exercises.

WORKSHOP V:

A Workshop in Transformation-Attunement, Attachment, Resonance and Sensory Integration

This pre-conference workshop will allow participants to practice specific body-mind components of the trauma-focused Somatocognitive and Sensory Integration group-based intervention CBI®. CBI's two principal body-mind foundations derive from (1) dance-movement therapy adaptations developed for the early intervention program known as Rainbowdance® and (2) transformative ancient Taoist practices, distilled from the Asian internal arts of Tai Chi, Yi Chuan, Chi Kung, and Aiki. These focus on the reflective aspect of dyadic relationships, which is the foundation for safe attachment.

WORKSHOP VI:

Beyond Words: The Use of Art Therapy in Trauma Work

This workshop introduces an art therapy framework for trauma treatment. Art therapists learn to attune to the nonverbal cues of their clients and develop a lexicon for the kinesthetic properties of art. This hands-on, highly experiential workshop, with slides, case examples, and discussion, provides a trauma frame for affect regulation, safety, and stabilization.

WORKSHOP VII:

Trauma-Induced Loss of Brain Integration: Use of Muscle Biofeedback and Acupressure to Release Trauma and Reintegrate Brain Function

Charles Krebs, PhD

LEAP® (Learning Enhancement Acupressure Program), developed by the presenter while recovering from a severe spinal cord injury, is based on the premise that all learning depends on the synchronized timing of neural activity in the brain. LEAP® Brain Integration seeks to re-establish the synchronized timing of brain activity through acupressure and other techniques based on Chinese medicine, combined with modern muscle biofeedback techniques. This workshop will demonstrate various techniques involving the assessment of brain integration via direct muscle monitoring, as well as acupressure techniques that rapidly release extreme states of arousal in order to defuse traumatic feelings.

The Dhamma Brothers

Thursday, June 4 • 7:30 p.m. - 9 p.m.

Jenny Phillips, cultural anthropologist, writer, and practicing psychotherapist, released this documentary film in 2008 which tells the story of a group of inmates inside a maximum-security prison in Alabama participating in a 10-day intensive vipassana meditation program. In addition, Jenny has published *Letters From the Dhamma Brothers*, which documents their lives in prison and their quest for inner peace.

COURSE DESCRIPTION

The study of psychological trauma has been accompanied by an explosion of knowledge about how experience shapes the central nervous system and the formation of the self. Developments in the neurosciences, developmental psychopathology, and information processing have contributed to our understanding of how brain function is shaped by experience, and the understanding that life itself can continually transform perception and biology. Within the disciplines of psychiatry and psychology, the study of trauma has probably been the single most fertile area in developing a deeper understanding of the relationship among the emotional, cognitive, social, and biological forces that shape human development. Starting with post-traumatic stress disorder (PTSD) in adults and expanding into early attachment and overwhelming experiences in childhood, this endeavor has elucidated how certain experiences can “set” psychological expectations and biological selectivity.

We have learned that most experience is automatically processed on a subcortical level, i.e., by “unconscious” interpretations that take place outside of awareness. Insight and understanding have only a limited influence on the operation of these subcortical processes. When addressing the problems of traumatized people who, in a myriad of ways, continue to react to current experience as a replay of the past, there is a need for therapeutic methods that do not depend exclusively on understanding and cognition.

OBJECTIVE

The objective of this course is to present current research findings on how people’s brains, minds, and bodies respond to traumatic experiences, how they regulate emotional and behavioral responses, and the role of relationships in protecting and restoring safety and regulation.

We will explore post-traumatic responses at different developmental levels, as well as the treatment implications of these findings. We also will explore how affect regulation and the interpretation of innocuous stimuli as threats require interventions aimed at restoring active mastery and the capacity to focus on the present. Traumatic memories often are dissociated and may be inaccessible to verbal recall or processing. Therefore, close attention must be paid to the development of inner resources to deal with dysregulation and helplessness, as well as the careful timing of the exploration and processing of the traumatic past.

In closing, the course will examine cutting-edge treatment interventions for various trauma-based symptoms.

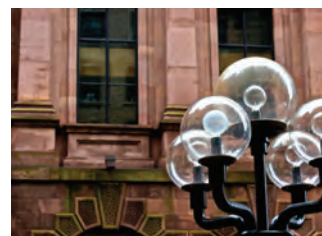

Prizes will be awarded during the evening poster session/social hour.

Proposals should be no longer than 200 words, excluding proposal title, author names, author affiliations, and contact information (email/phone) of the lead author.
